### **ADMISSION CRITERIA FOR NURSING TRANSITION**

\_ Attend a new student orientation, if applicable

Admission to Nursing requires the following minimum requirements, which must be completed prior to application. Completion of minimum requirements <u>does not</u> guarantee admission.

- Accepted SSCC student
- High school graduate or GED recipient
- Nursing Transition Application and Responsibility Form
- Practical Nursing school graduate; PN knowledge retention is essential
- Prerequisite courses with a grade of C or higher (C- is not acceptable). Knowledge of prerequisite content is expected. If taken more than 5 years ago, it is <u>strongly recommended</u> that course be repeated.
  - o CHEMISTRY (must meet at least one criteria)
    - High school chemistry
    - CHEM 1120
    - CHEM 120 and 122
    - Higher level college chemistry course
  - o BIOL 1510/1511, Anatomy & Physiology I (BIOL 1104 prerequisite may be required)
  - o BIOL 1520/1521, Anatomy & Physiology II
    - If A&P taken under quarters, BIOL 205 <u>and</u> BIOL 206 <u>and</u> BIOL 207 all must be completed with a grade of C or higher in each course.
