



### **PURPOSE OF THE SCHOLARSHIP**

Bagshaw Enterprises, Inc. along with the Southern State Community College Foundation have invested scholarship dollars to assist Southern State Community College students employed at their area Kentucky Fried Chicken (KFC) or Long John Silvers (Wilmington or Jeffersonville) locations with the cost of education. The number of scholarship awards will vary depending on funding availability.

### **ELIGIBILITY FOR THE SCHOLARSHIP**

In order to be eligible for the scholarship, the student(s) must:

- Have earned a high school diploma or G.E.D. equivalent.
- Be registered and attending as a full-time student at Southern State Community College.
- Be employed, maintaining at least 12 hours of continuous employment, at a KFC or Long John Silvers operated by Bagshaw Enterprises, Inc.
- Must be a current, hourly employee
- Maintain a 2.6 GPA or higher.
- This scholarship is intended to be used only at Southern State Community College.

Applications will not be processed unless they are complete and received by March 15th preceding the academic year. A complete application includes the following:

1. A typed or printed application
2. A grade transcript, which includes a cumulative grade point average
3. Proof of employment by either KFC or Long John Silvers, attaching a copy of your most recent check stub.

### **WHERE TO APPLY**

Applications will be available in the Financial Aid Office in Hillsboro or on the College's website at [www.sccc.edu/admissions/scholarship.htm](http://www.sccc.edu/admissions/scholarship.htm). Applications may be requested by phone by calling 1 (800) 628-7722 or (937) 393-3431, extension 2610. Applicants assume all the responsibilities for the following:

1. Obtaining a transcript from the first year of higher education.
2. Returning or following up to see that all parts of the application have been sent to the Financial Aid Office.

### **HOW AWARDS ARE MADE**

Candidates are selected by the KFC appointed scholarship selection committee. Bagshaw Enterprises, Inc will determine the number of scholarships annually. Recipients must re-apply each year. If selected as a recipient, the student will receive an award of \$200 for three consecutive quarters, totaling \$600 a year, as long as employment is continuously maintained. Employment verification must be provided by the student, via most recent check stub, at the start of each quarter to the College's Financial Aid Office before monies are distributed.

### **DISBURSEMENT OF THE SCHOLARSHIP MONIES**

Funds will be disbursed directly to the student's account at the College after the drop/add period of the quarter, after grade point average and enrollment status of the student has been verified. Scholarships for any one person shall not continue beyond the period of attendance at SSCC. Scholarships will be paid to each recipient in installments coordinated with the quarterly calendar.
