Dr. Boys recommended its consideration and approval, which would strengthen the College's resolve to support them and continue to deliver high-quality service.

## **Financial Reports**

In addition to his written report, Mr. Jim Buck reported on the recently completed financial audit conducted by Millhuff-Stang, CPA, Inc. There were no issues to report and no recommendations, which was good news. He also shared that there were three sealed bids from the sealed-bid auction on October 23 for the Fincastle (South campus) property. None of the bids were accepted. There was also a successful equipment auction held on October 31.

Mr. Buck discussed the public hearing with the Eagle Township Zoning Board held on November 11. The College requested that the Fincastle property be re-zoned as commercial, rather than agricultural. The board appeared reluctant to approve, and will submit an answer within 30 days. They showed concern for a potential commercial buyer and usage of the building and property. Discussion ensued with Trustee Pell regarding our ability to sell with that contingency, as well as the issue of tax revenue if re-zoned as commercial. Trustee Pell also

Their presentation to the Board included information about the need for soft-skills training for employees (instead of just technical), training development and feedback. The feedback was exceptional, and moving forward they will continue to build on this type of training. Chair Boedeker suggested getting in touch with Vickie Davidson at Fayette County Memorial Hospital to share ideas, as they do a similar training and recognition, offering refresher courses every six months. Dr. Boys and Trustee Pell both applauded Dr. Wise and Mrs. Markey-Grabill for their efforts.
