He recognized one of those retirees, Marilyn Jones, who was recently awarded the Excellence in Practical Nursing Education Award from the Ohio Organization of Practical Nurse Educators (OOPNE) at the state conference in March. He also highlighted that SSCC's revised Default Prevention Plan had been approved.

Trustee Moore inquired if the Truck Driving Academy program has been approved for non-credit financial aid. The answer was given that it was included in the House Budget Bill (for any non-credit training), and is currently in the Senate.

Faculty Emeritus

Trustee Moore moved and Trustee Hall seconded to approve Randall Massie as Faculty Emeritus, based upon the written recommendation (below) of the Faculty Senate, read aloud by Dr. Boys.

"Mr. Randall L. Massie has served as an Associate Professor at Southern State Community College for six years in the Human and Social Services Program (HSSR). He received the Excellence in Teaching Award in 2014 from SOCHE. Even though Randall's tenure was cut relatively short due to illness, his impact was not reduced by this short teaching span. Randall served one term as Faculty Senate President. He served as Southern State Education Association President for two terms. Also, Randall served on two SSEA negotiating teams and was very active on many college committees.

The HSSR program has steadily increased qualitatively and quantitatively over Randall's time of service. He brought a sensitivity and professionalism to the Human and Social Services Program. These skills were developed while Randall served as an Ordained Minister to churches throughout Ohio, Indiana, and Pennsylvania for approximately twenty years. He added a Master of Arts in Counseling toward the end of his ministry to transition to Licensed Professional Clinical Counselor in 1999, in the state of Ohio. Randall continued his professional development by becoming a Licensed Independent Chemical Dependency Counselor in 2000.

Randall attained a Bachelor's of Arts in Religion from Illinois College. He received two Master's degrees, one in Ministry and one in Counseling from Cincinnati Bible Seminary in the 1990's. All have heard his billowing laughter in the halls and have seen the quiet sobbing coming from his classroom. Randall did not just teach his students but he engaged them on a level that many are unable to do. Randall's teaching gift is well known and documented by the legacy of successful students.

For these reasons, I proudly recommend that Mr. Randall L. Massie be granted Emeritus status as an Associate Professor in the Human and Social Services

Program.
