# **Monitoring Confirmation**

#### **President's Report**

From his written report, President Boys highlighted Travis Martin and Toni Penwell's recent nominations for the SOCHE Excellence in Teaching Award, commending both outstanding individuals. He also brought special attention to the College Credit Plus section, with schools and statistics listed, noting that there are still around 200 applicants to add to the list. Several Board members commented positively on the increased numbers and new schools on the list.

President Boys shared with the Board about some information he learned the previous day at the OACC Presidents meeting. The College has the ability to charge a Career Services fee, if they choose. There has been discussion previously about expanding the Career Services Counseling and also utilizing some type of guided pathways app to aid the students. A proposal will be presented to the Board at the October meeting.

## **Financial Reports**

In addition to his written report, Mr. Jim Buck updated the Board on the latest status of enrollment. Although the budget planned for flat enrollment, the current reports are down 4-6%,

with every 1% representing \$80,000. He shared that those numbers could change just a bit, due to late applications for CCP students, and that there should be enough cushion in the budget to absorb the decline at this point.

He also reported that the closing on the Adams County property would take place at 3:30 p.m. on Monday. He addressed a few questions from the Board regarding an easement, new access road, lanes, utilities, etc.
