Monitoring Confirmation

President's Report

In addition to his written report, President Boys introduced an Economic Development Summit event that SSCC will be hosting in late April. This will bring parties such as the Highland County Chamber of Commerce, Highland County Commissioners and the city of Hillsboro together for better communication in economic development efforts. He thanked the trustees for their speedy cooperation in scheduling a New Trustee Orientation, and also commended Dr. McCall for his work and leadership on the RAPIDS grant, including three proposals requesting \$1 million to purchase equipment for healthcare training, environmental health and safety and advanced manufacturing. President Boys ended his report with an update on our work with BHDP Architects for preliminary development of an Adams County Campus. He reported that they are engaged and working on program elements. SSCC is still looking into options for funding the remaining \$3 million for the project.

Financial Reports

Mr. Jim Buck had nothing further to discuss regarding the written financial reports. He shared that the Fall/Spring projections were on target with flat enrollment, and that it was still too early to tell for the Summer semester. He also updated the Board on the progress with the South Campus property, and that a closing is scheduled for the beginning of June.

Trustee Moore questioned continued access to the Appalachian Gateway Center. Dr. Boys responded that it would be up to the new buyer what arrangements they work out with the Appalachian Gateway Guild and that arrangements seemed favorable. Some discussion also ensued about a request for soil to be auctioned off at the Brown County Campus, and regarding any restrictions on nearby land for sale.

Finance Committee Report

Following a report presented by Trustee Kyle Rudduck on behalf of the Finance Committee, the Committee recommended to (1) approve a 2% tuition increase for FY 2016 (subject to any restrictions in the State of Ohio's 2016-17 biennial budget legislation), (2) approve the FY 2016 preliminary budget, and (3) accept United Health Care's 5% rate increase (2.49% effective rate increase to the College). Mr. Buck commented that a 2% increase in tuition is conservative with a flat enrollment and limited additional resources, and would still keep SSCC as one of the lowest in tuitions in the state of Ohio.
