Monitoring Confirmation

President's Report

In addition to his written report, President Boys announced and expressed his appreciation for the

recent acknowledgement of a donation by the late Dorothy Shanks. Through her living will and testament, \$15,000 was left to the SSCC Foundation to establish a scholarship for Highland County SSCC students, off of the fund earnings. He also highlighted the recent formalized partnership with Wilmington College with the 2+2 biotech agreement, allowing SSCC students to live on Wilmington Campus for the first two years before transferring. He expressed appreciation to faculty member David Garippa for his extensive work in that program. President Boys also discussed the Festival of the Bells event that will be hosted by SSCC in July 2018, appreciation to Trustee Boedeker for his participation in Adams County architect selection, and details of a proposal for an ARC grant for \$250,000 to equip the Adams County campus in various areas, thanking Amy McClellan for working out the details of the grant.

Approval of Report and Resolution on Duplicative Programs

President Boys explained that as a result of the budget bill, the Board is required to take a look at duplicative programs, comparing offerings at nearby institutions and review recommendations. Dr. Nicole Roades prepared a report on duplicative programs and a resolution. It was noted that enrollment has been down in the Respiratory Care program and is being watched, despite a tremendous reputation in our area. The resolution was read as follows:

Resolution on Reporting Duplicate Programs

Whereas the Board of Trustees evaluated programs identified as “duplicative” by the Ohio Department of Higher Education,

And Whereas evidence in that evaluation demonstrated responsible action concerning the program review system and emerging program vitality measures as it is applied to the Colleges academic programming,

And Whereas the Chancellor of the Ohio Department of Higher Education has provided additional guidance concerning the reporting of the required evaluation per ORC 3345.35;

Be it resolved that Southern State Community College Board of Trustees approves the methodology and rationale for leaving select programs in their current form and targeting select programs for continued monitoring as reported at its meeting of November 29, 2017;

And be it further resolved that the Board authorizes the President to submit this data to the Chancellor.

Approval of Resolution for Local Administration of Adams County Project

President Boys clarified that “local administration” referred to Mr. Jim Buck being the one to administer funds for the Adams County project, rather than a state architect. Mr. Buck committed to using all approved state documents, as was done through the architect selection process, and noted that this approach could save around \$80,000 with additional hurdles avoided.
