# **Monitoring Confirmation**

#### **President's Report**

President Boys congratulated Trustee De Bruin and Trustee Prickett, as well as expressed his appreciation to Trustee Pell for his two years of service as Chair. He elaborated on several items from his written report, beginning with the new biennium capital budget and SSCC's required submission of a six-year capital plan (2019-2024). The priorities (in order) for any newly awarded capital funds would be applied toward renovations in the Health Sciences Department, sidewalk door and window projects at Central Campus, and renovation of the Student Study Center at

North Campus. President Boys shared details of his recent meeting with the Governor and K-12 business leaders at the "Jobs and Skills of the Future" meeting in Columbus, which focused on the future of education, emphasizing skills and knowledge verses degrees. He also explained a timeline to renew SSCC's strategic plan. In the spring, an environmental scan/SWOT analysis will be conducted (internal and external), and in the summer/fall, priorities will be identified for the next several years.

# **Financial Reports**

Mr. Jim Buck had nothing to add to his written report. He commented that enrollment appeared to be down between 2.5% and 4%, and numbers could be finalized in the next few days, after the final day to drop/add a class.

#### **Approval of BHDP Architecture Service Contract Resolution**

President Boys thanked Trustee Boedeker for joining he and Mr. Buck in reviewing project proposals from 17 architect firms. All three agreed on the top three firms to interview, and BHDP Architecture was unanimously chosen. The following resolution was presented to the Board:

#### **Resolution re: Professional Design Services for Adams County Satellite Campus Project**

WHEREAS, the College received and evaluated seventeen responses to a request for qualifications related to design services for the new satellite campus in Adams County; and

WHEREAS, from a shortlist of three interviewed firms, BHDP Architecture was selected;

BE IT RESOLVED, that the Southern State Community College Board of Trustees hereby approves a professional service contract with BHDP Architecture in the amount of \$381,000, which includes basic services of \$225,000, additional services of \$112,500, including inspections and testing, and reimbursable expenses not to exceed \$43,500.

# **Approval of ARC Grant Resolution**

President Boys explained that this grant request was for the maximum amount, \$250,000, and stands a good chance of being approved. He thanked Amy McClellan, Jeff Montgomery and Nicole Roades for their diligent work in putting the grant application together. The following resolution was presented to the Board:

#### **Resolution of Support for Appalachian Regional Commission Grant Application**

WHEREAS, the Southern State Community College Board of Trustees has established the mission of providing affordable, accessible, and high-quality education in our service area and beyond; and

WHEREAS, in furtherance of this mission the Board of Trustees has recently purchased land for the purpose of establishing a more accessible education and training facility for the residents of Adams County; and

WHEREAS, Adams County, in particular, lags the state and region in educational attainment; and

WHEREAS, a recently announced closure of a major employer located within the county places additional stresses to the economic vitality of the county; and

WHEREAS, Southern State Community College endeavors to build the economic capacity through providing post-secondary education and workforce training with a focus on Information Technology, Cloud Computing, and Manufacturing Engineering; and

WHEREAS the close proximity of this new facility to the Secondary Career Technical Center facilitates a close working relationship creating new educational pathways to students; and

WHEREAS, the Southern State Board of Trustees seeks additional resources to equip its facility with the required computers, virtual learning classrooms, and manufacturing equipment and simulators;

BE IT RESOLVED, that the Southern State Community College Board of Trustees hereby supports this effort, authorizes the President to file this grant application with the Appalachian Regional Commission, and commits to the financial match required in Adams County.
