Adams County Campus Update: Construction Bids

Mr. Buck shared that the lowest base bid submitted for construction of the Adams County Campus was \$1.3 million over the advertised estimate of \$3.25 million dollars. State law (section 153.12 of the Revised Code) prohibits a state entity from entering into a contract on a project that exceeds its estimate by 10% or more.

Dr. Jessica Wise, North and Fayette Campus Director, gave a brief update of happenings at North Campus. Excel training (funded by Clinton Co. Ohio Means Jobs) was held for Deluxe Technicolor, Cox Auto and ATI. Upcoming continuing ed programs include license renewal workshops for water/wastewater operators and also STNA training. Dr. Wise also shared that there have been a total of 46 students complete the Truck Driving Academy since July.

Amy McClellan was recognized for her efforts in helping facilitate a partnership with the Clinton and Highland County's Department of Disabilities Board, offering classes at North Campus on Tuesdays and Thursdays during the Fall term. She noted that there are 10 students participating in the non-credit program (7 from Clinton Co. and 3 from Highland Co.), who all very much appreciate and enjoy being a part of the College.
