# President's Report

From his written report, Dr. Boys highlighted the GRIT grant award, commending Dr. Nicole Roades for her extensive work to make that award happen for SSCC and Highland County. He commented that Adams County also received a GRIT award, and the possibility of working together to take advantage of these opportunities for short-term programs. He also updated the Board on the capital bill request, effective July 1, 2020, of \$1.7 million as SSCC's share, noting that all 23 Ohio community colleges must agree on the distribution amounts. Campus surveys were distributed online to students, faculty and staff for feedback regarding campus needs and future renovations. He noted that the participation was encouraging, and walk-throughs of each campus are scheduled for next week.
