Monitoring Confirmation President's Report

President Boys acknowledged the importance of this humbling and celebratory day of graduation, the day worked for all year long, with many overcoming huge obstacles. He highlighted a few items from his written report, including details of the adjusted summer schedule and equipment received through the RAPIDS grant. In addition to his written report, he gave an update on a few state budget items, including a possible increase of \$5 per credit hour, 1% increase to SSI, OCOG re-instatement and a potential bond levy for permanent improvements to state community colleges. He expressed gratitude to Representative Shane Wilkin for his efforts lobbying for the \$5 per credit hour increase, and also noted that the current legislators are very sympathetic to the needs of the College and appreciate the work done here.

However, is was noted that two weeks still remain for registration. He shared with the Board that there should be a balanced budget by the June meeting for approval.
