President's Report

President Boys shared the unfortunate news of the passing of Dr. Shane Shope, a long-time educator in the Lynchburg-Clay school district, professor at Morehead State University and Project Director of the Ohio Code Scholar project, mentioned in his written report. He also acknowledged the retirement of Dr. David Garippa and noted the high level of involvement and positive impact on his students. He reported exciting news of the College's Senate Bill 6 score of 3.6, highest in over a decade, and also elaborated on his paragraph in the written report about SSCC's capital bill request.

Approval of Resolution Establishing Stabilization Fund

After a brief introduction of the resolution by President Boys, Trustee Cummings moved and Trustee Boedeker seconded that the Board accept the following resolution for the establishment of a stabilization fund with the proceeds from the sale of North Campus:

**SOUTHERN STATE COMMUNITY COLLEGE BOARD OF TRUSTEES
NOVEMBER 17, 2021**

Resolution Establishing a Stabilization Fund

Whereas the Higher Learning Commission (HLC) has established a set of criteria by which an accredited College can demonstrate financial stability;

And whereas Ohio's Senate Bill 6 establishes a metric for a similar purpose;

And whereas the Composite Financial Indicator (CFI) is the metric by which the HLC reviews the state of financial stability on an annual basis;

And whereas Southern State Community College has, on its CFI, scored below the zone found acceptable to the HLC;

And whereas the Board of Trustees has approved through its strategic plan, a plan to improve its CFI, SB6 ratio, and cash balances for long-term sustainability;

And whereas, one of the strategies employed resulted in the sale of the Southern State Community College's North Campus at a sale price of \$1.2 million dollars significantly improving the cash balance;

Be it therefore resolved that the Southern State Board of Trustees hereby establishes with the proceeds of that sale, a stabilization fund, which shall be restricted to emergency use.

Dr. Roades expressed her gratefulness, being honored and humbled with their decision.


Adjournment
