### Monitoring Confirmation President's Report

In honor of his last Board meeting, President Boys revisited the question he asked when he first arrived at the College ... "What would our area look like without Southern State Community College?" He answered by sharing some statistics during his tenure, including over \$25 million saved by College Credit Plus students, nearly 1,000 graduated nurses and dozens of respiratory therapists, along with those who earned their GED or high school diploma through 22+, and close to 2,800 who have earned their CDL. He expressed his appreciation to the Board for their support and tough decisions over the years, his team for their encouragement and support, gave special honor to the faculty, and with emotion, expressed his gratitude for his wife Diane, present at the meeting, for her unconditional support at home.

#### **OPERS Resolution**

Upon entering back into regular session, Trustee Prickett moved and Trustee Chandler seconded that the Board accept the following resolution:

RESOLUTION THAT THE SOUTHERN STATE COMMUNITY COLLEGE WILL PICK UP THE STATUTORILY REQUIRED CONTRIBUTION TO THE OHIO PUBLIC EMPLOYEES RETIREMENT SYSTEM FOR CERTAIN EMPLOYEES OF THE SOUTHERN STATE COMMUNITY COLLEGE PURSUANT TO IRC SECTION 414(h)(2).

WHEREAS, pursuant to federal and Ohio laws, the Southern State Community College may offset future salary increases and "pick up" (assume and pay) the contributions statutorily required by such elected officials and covered employees to the Ohio Public Employees Retirement System (OPERS)

and such individuals will not be required to pay federal and state income taxes on such contributions; and

### NOW THEREFORE BE IT RESOLVED BY THE SOUTHERN STATE COMMUNITY COLLEGE, THAT:

SECTION 1: Effective July 1, 2022 the full amount of the statutorily required employee contributions to OPERS shall be picked up and paid as a fringe benefit by the Southern State Community College for each person within any of the classes established in Section 2 herein. The pick-up shall be an offset against future salary increases. This "pick up" by the Southern State Community College shall be designated as public employee contributions and shall be in lieu of contributions to OPERS by each person within any of the classes established in Section 2 herein. No person subject to this "pick up" shall have the option of choosing to receive the statutorily required contribution to OPERS directly instead of having it "picked up" by the Southern State Community College or of being excluded from the "pick up". The Southern State Community College shall, in reporting and making remittance to OPERS, report that the public employees contribution for each person subject to this "pick up" has been made as provided by the statute. Therefore, contributions, although designated as employee contributions, are employer-paid, and employees do not have the option to receive the contributions directly. All contributions are paid by the employer directly to the plan.

SECTION 2: The "pick up" by the Southern State Community College provided by this resolution shall apply to the President and Vice President for Academic Affairs who are employees of the Southern State Community College who are or become contributing members of OPERS.

SECTION 3: Under the fringe-benefit method of employer pick up, salary is not modified; however, the employer will pay the employees' statutorily required contribution to OPERS.

SECTION 4: The treasurer and/or the clerk are hereby authorized and directed to implement the provisions of this resolution to institute the "pick up" of the statutorily required contributions to OPERS for those persons reflected in Section 2 herein so as to enable them to have their employee contributions paid by their employer.
