SSCC's requests to utilize monies previously directed to the Regional Partnership and Training Center in South Point, Ohio for technical training offered in our service region of Adams, Brown, Clinton, Fayette, and Highland Counties. Other unused capital funds of a commensurate amount were directed to the Tri-State S.T.E.M.+M Academy in South Point.

He also highlighted the health insurance recommendation, and advantages of the consortium, as well as expressed congratulations to Dr. Angel Mootispaw for successfully defending her dissertation to earn a Doctorate of Instructional Design Leadership from Franklin University, and to Dr. Julie Krebs for her election as Chairperson for the Ohio Council of Associate/Diploma Degree Nursing Education Administrators.

Dr. Steven Hinshaw shared that revenue was up 18% compared to last year, and highlighted the new "one-time revenue" line in the written reports. He also discussed the SSI and expense figures, noting that the College is doing well all around. After looking into refinancing debt through Fifth Third Bank, he noted that due to current interest rates, the College will not pursue
