Consideration of Resolution Authorizing Delivery of Deed and Closing Document Signing

Trustee O'Hara moved and Trustee Chandler seconded to approve the following resolution to authorize the College President to deliver the executed Governor's deed and to sign closing documents along with the Board Chair:

Resolution to authorize the College President to deliver the executed Governor's Deed to the 1270 US Rt. 62 SW, Washington Courthouse, Ohio 43160 property in Fayette County, Ohio (hereafter "1270 U.S. Rt. 62 property") to Kettering Network Services, upon appropriate payment as required by the Real Estate Purchase Contract, and to authorize the Board Chair and the College President to sign closing documents associated with the conveyance of the 1270 U.S. Rt. 62 property to Kettering Network Services, and also to sign a Non-competition Agreement between Southern State Community College and Kettering Network Services, an Ohio non-profit corporation as referenced in the said Governor's Deed

WHEREAS, on December 15, 2021 the Board of Trustees adopted a Resolution authorizing the divesture of both the land and the building that comprises the real property owned by Southern State Community College and located at 1270 US Rt. 62 SW, Washington Courthouse, Ohio 43160 in Fayette County, Ohio (hereafter "1270 U.S. Rt. 62 property")

WHEREAS, on December 15, 2021 the Board of Trustees adopted a Resolution authorizing the Board Chair and the College President to sign a Real Estate Purchase Contract, concerning the 1270 U.S. Rt. 62 property, with Kettering Network Services.

WHEREAS, on December 15, 2021 Brian L. Prickett, Chairman of the Board of Trustees and Kevin S. Boys, President, both of Southern State Community College, did then sign a Real Estate Purchase Contract with Kettering Network Services for the 1270 U.S. Rt. 62

property.

WHEREAS, a Governor's Deed for the conveyance of the 1270 U.S. Rt. 62 property to Kettering Network Services has now been fully executed and is in the possession of counsel for Southern State Community College so that the transaction is now ready for closing.

BE IT RESOLVED, that the Southern State Community College Board of Trustees hereby authorizes Nicole Roades, President of said College, upon payment of the purchase price agreed to in the previously executed Real Estate Purchase Contract, to deliver the Governor's Deed to the 1270 U.S. Rt. 62 property to Kettering Network Services and further authorizes Nicole Roades, President, and Kyle Rudduck, Chairman of the Board, both of Southern State Community College, to sign all customary closing documents, including a closing statement, that are appropriate to consummate and memorialize the sale of the 1270 U.S. Rt. 62 property as above described, and also, both to sign the Non-Competition Agreement between Southern State Community College and Kettering Network Services, an Ohio Non-Profit Corporation, as the same is referenced in the Governor's Deed.

WHEREAS, pursuant to section 5(e) of the Second Supplemental Trust Agreement between Southern State Community College and the Bank of New York Trust Company securing \$2,805,000 of General Receipts Bonds Series 2008 dated June 1, 2008, the original Series 2003 Bonds shall be subject to optional and mandatory redemption on such dates and terms approved by at least two of the following officials: the Chairman of the Board of

Trustees, the President, or the Fiscal Officer, and

WHEREAS, pursuant to section 3.02 of the Trust Agreement between Southern State Community College and Fifth Third Bank securing General Receipts Obligations dated December 1, 2003, obligations shall be redeemed only by written notice from the College to the Trustee to redeem in accordance with the applicable Series Resolution;

THEREFORE BE IT RESOLVED, that Southern State Community College Board of Trustees authorizes the President to issue an "intent to redeem bonds" notice to the Bank of New York Trust Company and Fifth Third Bank pursuant to the Fayette Campus closing date for the outstanding Series 2003/2008 bonds in full.
