Consideration of Resolution to Adopt the Academic Plan to Develop American Civic Literacy Course

President Roades provided background information for the proposed resolution to adopt an academic plan to develop an American Civic Literacy Course, in compliance with Senate Bill 1. Trustee Kirk moved and Trustee Prickett seconded to accept the resolution as presented:

Southern State Community College Board of Trustees Resolution on Developing American Civic Literacy Course August 21, 2025

WHEREAS, the Board of Trustees evaluated the guidelines set forth by The Advance Ohio Higher Education Act (Ohio Revised Code - Section 3345.382) that requires state institutions of higher education to adopt a plan to develop an American civic literacy course of at least three credit hours and,

WHEREAS, all American Civic Literacy courses offered at Ohio public institutions are required to meet specific requirements of ORC Section 3345.382(B) and will be required to be approved as an Ohio Transfer 36 course, and

WHEREAS, the course may be offered under the College Credit Plus program and can be part of the institution's general education program and, beginning with the Spring semester of 2029-2030 academic year, students must complete the course in order to receive a bachelor's degree from any state institution;

AND WHEREAS, the course is designed to include the following required readings;

- (1) The entire Constitution of the United States;
- (2) The entire Declaration of Independence;
- (3) A minimum of five essays in their entirety from the Federalist Papers (essays selected by the department chair.
- (4) The entire Emancipation Proclamation;

- (5) The entire Gettysburg Address;
- (6) The entire Letter from Birmingham Jail written by Dr. Martin Luther King Jr;
- (7) The writings of Adam Smith, including the principles written in The Wealth of Nations.

AND WHEREAS, the students taking the course must also pass a cumulative final exam at the end of the course that assesses proficiency with the required documents, and

WHEREAS, there is evidence of responsible action concerning the development of the course under a qualified faculty member as political science general education course;

BE IT RESOLVED that Southern State Community College Board of Trustees approves the plan for the American Civic Literacy course as reported at is meeting of August 21, 2025.

Consideration of Resolution Authorizing Exemption from Student Requirement to Complete American Civic Literacy Course

In addition to the previous resolution, President Roades provided a brief explanation about the potential need for a student's exemption from the student requirement to complete the American Civic Literacy Course. Trustee Milstead moved and Trustee Chandler seconded to accept the proposed resolution as presented:

Southern State Community College Board of Trustees Resolution Authorizing Exemption from Student Requirement to Complete American Civic Literacy Course August 21, 2025

WHEREAS, the Board of Trustees approved a plan to introduce the American Civic Literacy course in its curriculum according to the guidelines specified in the Ohio Revised Code, Section 3345.382, also known as the Advance Ohio Higher Education Act, and

WHEREAS, the Board of Trustees must adopt a resolution specifying conditions under which the institution's president or designee may exempt a student under division (D)(3) of Section 3345.382, and

WHEREAS, exemption conditions of the following exist:

- 1.) Student has successfully completed an approved American Civic Literacy course that satisfies the content requirements as approved by the Chancellor through participation in the College Credit Plus
- 2.) Student has completed an advanced placement course and examination that satisfy the content requirements described in division (B) of Section 3345.382 and are approved by the Chancellor, and the student receives a score of three or higher on the examination;
- 3.) Student has completed at least three credit hours, or equivalent, in a course subject area of American history or American government

BE IT RESOLVED that the Southern State Community College Board of Trustees authorizes the President or designee to exempt students from taking the American Civic Literacy Course.
