Monitoring Confirmation President's Report

President Roades began her remarks with expressing gratitude to the SSCC maintenance team for their phenomenal job in clearing paths and keeping all safe during the snowy and cold weather. She noted a rocky start with Spring enrollment, which could partially be due to the weather. Exciting news followed, regarding a Campus Safety Grant award of over \$427,000, which was the 7th highest amount among Ohio colleges and universities who applied for funds from the \$7.5 million pool.

She shared other details and updates about: the recent Harwood Classic basketball tournament in the Patriot Center, Governor DeWine's efforts to strengthen jobs in the children's services field, appreciation toward Amy McClellan for becoming the main contact with our strategic enrollment consultant, the HVAC tower for Central Campus arriving this month, upcoming architect walk-throughs and interviews for the Computer Science Center of Excellence, and the progress of the Brown County land sale project.

Financial Reports

In addition to his written November and December reports, Dr. Steven Hinshaw noted that halfway through the fiscal year, revenue and expenses were within 1% of the budget. He expressed some concern about Spring enrollment, but was hopeful it would increase over the next week. He also shared great news about the College receiving an upgrade in Moody's

rating, the highest rating since 2016 and an achievement especially notable in a challenging current higher education environment.
