Consideration of Resolution Regarding Curricular Approval Process

President Roades expressed her appreciation for the solid, policy-following work of the Curriculum Committee, and provided an explanation and details surrounding the need for a resolution to approve a curricular approval process. Trustee Boedeker moved, and Trustee Newman seconded to approve the curricular approval process as presented below:

SOUTHERN STATE COMMUNITY COLLEGE BOARD OF TRUSTEES October 16, 2025

Resolution Affirming the College's Curricular Approval Process in Compliance with Ohio Revised Code 3345.457

WHEREAS, Ohio Revised Code 3345.457 requires each state institution of higher education to establish, implement, and maintain an internal process for the approval of all academic curricula, degrees, and certificate programs offered by the institution; and

WHEREAS, the statute further requires that the institution's governing board formally approve the institution's curricular approval process to ensure appropriate faculty involvement, administrative oversight, and alignment with state standards; and

WHEREAS, the Board of Trustees of Southern State Community College recognizes the importance of maintaining a clear, efficient, and collaborative process for curriculum development and review that supports academic quality, student success, and institutional accountability; and

WHEREAS, the College administration and faculty, through the Academic Affairs division and established governance structures, have developed and implemented a Curricular Approval Process that includes:

- Faculty-led curriculum development and review through the Curriculum Committee;
- Approvals of the Committee are forwarded as a recommendation to the Vice President of Academic Affairs (VPAA);
- Recommendations from the VPAA are directed to the President, followed by the President's submission to the Board of Trustees for formal and final action where applicable;
- Compliance with all applicable Ohio Department of Higher Education (ODHE) and Higher Learning Commission (HLC) requirements.

NOW, THEREFORE, BE IT RESOLVED, that the Board of Trustees of Southern State Community College hereby affirms and approves the College's Curricular Approval Process as consistent with the requirements of Ohio Revised Code 3345.457; and

BE IT FURTHER RESOLVED, that the Board directs the President or designee to ensure the continued documentation, implementation, and periodic review of the Curricular Approval Process to maintain compliance with state law and to support continuous improvement in academic program quality; and

BE IT FURTHER RESOLVED, that a copy of this resolution and the approved Curricular Approval Process shall be maintained in the official records of the Board and made available for inspection as required by law.
