SUBJECT: August 31, 2020 Financial Reports

Please review the accompanying Financial Reports. We have not reached our official drop/add period for Fall Term and a significant portion of College Credit Plus course enrollments at the high schools are not fully complied. However, at this point it appears that Student Fee revenue projections should be reasonably close (plus or minus 2%).

We are hearing greater confidence that the new State funding numbers are likely to remain steady. The significant improvement over earlier projections provided by the State in our level of support (-4.38 % vs. -20%) along with a corresponding pause in a portion of cost reductions has made it necessary to provide an early correction budget for the current fiscal year. It has been provided for your consideration.
