SUBJECT: January 31, 2020 Financial Reports

Please review the accompanying Financial Reports. As of this date Spring Term enrollment is down -6.8% from last Spring Term, with dramatically different results for College Credit Plus students (a positive 1%) and non-CCP students (negative -15%). Provided the coming Summer Term is comparable to last year, it is estimated that annual enrollment will be down approximately -5%. You will recall that our current budget was built on an enrollment decline of -4%. The revised budget that I plan to present for your consideration at the March Board meeting should include a -3% reduction in both total revenues and expenses, and retain the estimated surplus of \$350,000.
