SUBJECT: June 30, 2020 Financial Reports

Please review the accompanying Financial Reports. General Fund Revenues for FY 20 fell short of estimates by -2.4%, which was more than offset due to actual expenditures being -4.8% below projections. The year ended with an annual operating surplus in the General Fund which was 4.6% of actual revenues. The General Fund Balance as of June 30, 2020 was 30% of General Fund expenditures.

The College has been informed that FY 2021 State Funding will begin the fiscal year with a reduction of -4.38%, as opposed -20 % which had previously been discussed. If the level of actual funding continues in this new fiscal year it will have a very significant positive impact on our budget. A word of caution, however, surrounds enrollment projections which directly impact Student Fee Revenue. As of this date it remains too early to determine what portion, if any, of the budget gains in state funding will be offset by enrollment losses beyond those previously included in our projections.
