# **Governor's Proposed Budget for Higher Education**

Governor John Kasich has once again introduced budget recommendations for higher education that continue to bring about reform, provide small increases to the state share of instruction (SSI), restore Ohio College Opportunity Grant (OCOG) funding for community college students who attend school in summer sessions, strengthen high school participation in College Credit Plus, and reduce the cost of attendance at Ohio's colleges and universities. I will share more detailed information during the meeting.

# Analysis of FY2015 State Funding Distribution for Ohio's Community Colleges

Enclosed is an Ohio Association of Community Colleges (OACC) document, "Institutional Analysis of FY 2015 Funding Distribution," that shows our college's share of instruction utilizing the performance funding system now in place and contrasts each performance area against the previous funding metric of enrollment only. As you will see, Southern State is doing quite well under the new performance funding formula. I'll provide additional explanation during the meeting.

# **Student Loan Default Rate Draft Shows Improvement**

The college has received the **draft** cohort rate for the 2012 year. The draft rate is 28.5 percent which reflects a decrease in the rate of 2.9 percent. The official rate will be released in September. Historically, the actual rate is never higher than the draft rate. As you will recall, it is critical for colleges to have three-year default rates of less than 30 percent. The financial aid team is in the process of reviewing the data to determine whether an appeal/challenge of the rate could be submitted to lower our rate further.

# **Nursing Program Pass Rates Success**

As was stated in the last report, the first-time pass rates for nursing licensure examination for the Practical Nursing graduates have been 100 percent for the past four years. This achievement has resulted in a **No. 1 national ranking** as noted in the NCLEX Program Report published by the National Council of State Boards of Nursing. An additional interesting point is the national mean passing for the NCLEX-PN is 82.16 percent for 2014.

The most recent NCLEX Program Report identifies the Southern State Community College Associate Degree Nursing Program graduates ranked **in the top 10 percent of all nursing programs in Ohio** based on the percentage for graduates passing the NCLEX-RN during April-September 2014. Ninety-five percent of graduates tested successfully during this time period. For the entire 2014 year, Southern State's ADN passing rate was 89.55 percent. This is compared to a national mean of 81.79 percent and an Ohio mean of 77.18 percent.

The entire nursing department is to be commended for the time, dedication, and hard work they demonstrated to achieve these rankings. Due to their extraordinary efforts, the students leaving the nursing program are prepared to enter the workforce and obtain well-paying jobs.

# Accelerated Real Estate Courses 🗹

In an effort to revitalize the real estate program as well as serve community needs and promote our alliance with the real estate community in our service areas, Southern State's business division has been making some changes to the timing of the licensing classes. The state of Ohio requires four specific real estate classes that must be passed as a condition for taking the Real Estate Salesperson's License exam. The department has run these classes, but over the last few years the classes have not filled to minimum enrollment and have been cancelled. In part this was because of the economic recession, which was especially difficult in the real estate market. That market has improved and with the increase in sales and market values, inquiries into the classes increased. The courses have not been redesigned, but rather have recognized that for Realtors, time is money. In January, the college began an accelerated group of these classes which meet on Saturdays from 8:30 a.m. to 5 p.m. In the 15 weeks of spring semester, all four classes will be completed in this accelerated format. The response has been tremendous, with 16 students currently enrolled. Plans are being developed for an online review class that will be offered toward the end of these classes, and currently 12 students are enrolled.

In keeping with the idea of serving this community and giving our students the best chance of succeeding, we are planning to do the following:

- Hold the classes on different campuses each semester
  - o Spring Semester on Central Campus in Hillsboro
  - o Summer Semester on Brown County Campus in Mt. Orab
  - Fall Semester on Fayette Campus in Washington C.H.;
- Try different formats
  - 15-week accelerated classes (current)
  - Six-week accelerated classes (summer, weekend program);
- Invite local Realtors to lunch with our students in the accelerated classes;
- Meet with realty boards in our service area (met with Highland County Board of Realtors in February);
- Market the specific block of classes in addition to the usual class marketing;
- Strengthen the pool of instructors; and
- Work with SSCC's Workforce Development and Community Services to offer continuing education classes as well as the required 10 hours the state requires within one year of licensing.

# **Adult Opportunity Center**

#### **North Campus Visit**

The Adult Opportunity Center (AOC) was honored to host a number of state officials at North Campus in Wilmington as part of the activities surrounding the Governor's State of the State Address on Feb. 24. Board of Regents Chancellor John Carey, Vice Chancellor Gary Cates, SW Program Manager Marquita Mitchell, other representatives from the Board of Regents, and several members of the governor's staff were among the visitors who met with students and the AOC staff.

#### **Curriculum Meeting**

Southern State will host the next in the series of curriculum meetings at Brown County Campus in Mt. Orab on March 27. Programs are updating to reflect the changes of the new GED Test and the new Career and College Readiness Standards.

#### **Ohio Means Jobs**

The AOC is in the process of signing agreements with two of the local Ohio Means Jobs agencies to partner in providing academic services to clients, especially those who need a GED.

# Workforce Development and Community Services Truck Driving Academy

## **Truck Driving Academy**

All equipment and modifications of the equipment obtained through the Ohio Board of Regents (OBOR) grant has been completed. Some units are still waiting on the lettering and signage required by Ohio Department of Public Safety to properly mark the units as belonging to a licensed driver training school.  $\checkmark$ 

Enrollment in the Truck Driving Academy (TDA) for January and February was about the same compared to one year ago -- 43 for the two months in 2014 compared to 41 for

#### this year.

John Joy, SSCC Dean of Workforce Development & Community Services, participated as an exhibitor for the TDA at the Ohio Educational Technology Conference held Feb. 11-13 in Columbus. Based on the favorable response, the TDA has been invited back next year and plans to expand the booth size with the addition of planned partner Equinox. An additional meeting was held in February to further the partnership being sought with Equinox Business Solutions of Salt Lake City, Utah, to offer online training to existing and graduated TDA students. Additionally, the partnership will position the TDA as a leader in CDL training nationwide, as well providing the TDA a unique market position nationwide.

#### **Workforce Development**

The conversion of Room 318 on North Campus in Wilmington to a testing center was completed, and the North Campus Assessment Center began operations in January. A wide variety of computer, nursing, and other workplace-related testing functions are underway. Specific usage numbers will be provided beginning next month as the reporting process is implemented.

On Feb. 3, Vice President of Academic Affairs Dr. Ryan McCall, John Joy and faculty member Tom Smith met with Sinclair Community College administrators and faculty to develop the details needed to begin offering the two agriculture courses supplied by Southern State to the Precision Agriculture program offered through Sinclair.

## **Continuing Education, Community Services, & Departmental Notes**

John Joy was invited by Laurel Oaks Career Development Campus to participate in its regular accreditation process held Jan. 14-15. Based on the "High Schools That Work" model, the assessment process was a great opportunity to observe another learning organization first-hand and observe effective learning practices and the organizational factors that lead to learning outcomes.

On Feb. 24, North Campus in Wilmington hosted close to 100 visitors from the community and various levels of state and local government. The activities centered on the governor's visit to Wilmington to deliver his State of the State address. Dr. Andrew Shepherd from Sinclair Community College attended and provided visitors an update on the UAS Precision Agriculture program offered in partnership with SSCC.

The partnership with SALT (Money Knowledge for College – And Beyond), the third party vendor, has been launched to our current students in addition to our alumni. SALT will reach out to those borrowers in delinquency to assist them with repayment options to avoid default as well as enhance financial literacy for our current students.

The partnership with SALT will provide added resources to existing default management initiatives, which remains a priority within the department.

# **Spring Semester Disbursements**

Financial aid for spring semester to include federal grants, student loans, and scholarships has been disbursed, totaling \$4,742,248 to date.


