### **State Budget Update**

The Ohio Senate released its budget late last week and will be considering amendments before a vote is taken to approve and advance the budget to conference committee. The Senate did insert the Governor's proposed language to limit the State Share of Instruction (SSI) to in-state students. It is my position that it not only benefits 22 out of the 23 community colleges, but is most consistent with the intent of the SSI to support our work with students who contribute to Ohio's workforce and educational attainment goal. I hope to be able to share the final results of the budget bill at the meeting next week.

### **Short-Term Certificate Foster Youth Program Grant**

We were pleased to be one of the colleges receiving an award of \$20,263 from the Ohio Department of Higher Education to offer short-term certificate programs to young people who have "aged out" of the foster care system. This is an often neglected group of young people who do not have the familial support to pursue post-secondary education to better their lives. I appreciate the work of Amy McClellan who turned this grant around in a matter of days.

### \$50,000 Donation from Ann E. Fender Trust / Don Fender

The SSCC Foundation recently received a very generous donation at the bequest of the late Ann Fender. Ann and Don Fender have been extremely generous over the years through their scholarship fund. We are in discussions with Don as to a way to appropriately honor Ann's generous legacy within the renovation of the Health Science Center.

### **Southern State Community College Foundation Update**

The Southern State Community College Foundation Board recently approved the expenditure

of \$22,000 to enter into a consultant contract with the Armistead group. Dr. Armistead has worked with community colleges throughout the nation to assist them in strengthening their foundations to support college programming and student success. The Board also authorized its executive committee to explore and partially fund a position to staff the foundation once again.

### **Recommended Change to the Policy and Information Manual**

You will see on the agenda a recommended change to the Policy and Information Manual. As a matter of practicality, I am recommending that the Independence Day holiday be extended an extra day (to include the 5<sup>th</sup>) when Independence Day falls on a Thursday. There are no college classes scheduled on Fridays in the summer.

### **AACC Executive Committee Appointment**

I have been asked to serve on the executive committee of the American Association of Community Colleges for the 2019-2020 Academic Year. It is an honor to assist the incoming chair, Dr. Alex Johnson, in leading our nation's organization. As one of my duties, I will chair the Public Policy and Government Relations Committee.

### **English Department Hosts Faculty Development Workshop**

On May 22, Southern State English faculty hosted a workshop aimed at learning more about the design and instruction of co-requisite English courses as well as integration of publisher tools aligned with the adopted text. The first half of the workshop included a co-led faculty presentation delivered by Ms. Toni Penwell and Mr. Jason Reynolds. Invited guest, Dr. Kathleen Cleary, representing Ohio's Strong Start to Finish Initiative, was on hand to learn more about our practices in co-requisite remediation while also sharing insights from other partners across Ohio. The afternoon included a guided introduction of resources of the *Norton Field Guide and Norton Sampler*, facilitated by Ms. Jen Luongo representing Norton Publishing. Special thanks to Division Coordinator, Ken Holliday and the entire English Department in coordinating and hosting this workshop.

### Partnership with Shawnee State University to Offer Occupational Therapy Assisting Nearing Launch

In the making for nearly 18 months, the partnership with Shawnee State University to host a two-year Occupational Therapy Assisting program at Southern State's Hillsboro Campus is nearing reality. After months of accreditation and certification hoops, it appears as though the program will launch in fall 2019. Shawnee will deliver the technical instruction and Southern State will host the general education coursework.

This in-demand career field is projected to have 177 annual openings and a familysustaining entry wage of \$46,710 according to the Ohio Department of Job and Family Services. Additionally, this is a pathway degree that leads to an even higher demand for master's credentialed OTA's with even more job openings and higher wages. The introduction of this program in the Southern State service area saves prospective students from hours of commuting time as the nearest programs are approximately an hour drive from our area. And, partnering with an outstanding and reputable program as that which is led by Shawnee State, represents a tremendous opportunity for students and potential employers in our region.

### **Health Science Center Renovation Gaining Momentum**

Following the important work of aligning the capital appropriations and confirming the budget, the project has recently picked up momentum. In various meetings with App Architecture, College faculty and staff representatives assisted in the selection of material finishes as well as space utilization specifications. These meetings are an integral part of planning process and should result in an updated timeline for project commencement. The tedious work of building construction documents and updating timelines is the next chapter and will likely run through the remainder of summer 2019. For those areas that are directly impacted by this renovation, internal planning is underway to establish relocation strategies and timelines. As with all construction projects, effort to keep disruption to a minimum is the priority. In advance, the College's cooperation and flexibility is greatly appreciated.

### Summer Fill Rate Highest in Three Years and Exceeds Benchmark

Consistent with local and statewide expectations regarding efficiency, the faculty and staff work hard to maintain the ideal balance between course offerings and enrollment. While simple as it may sound, offering the courses students want and need at a time and location that they are able to take them, requires precision. Dr. Jessica Wise, alongside division coordinators, campus leaders, and faculty pour hours of planning and work to deliver on efficiency expectations. Summer 2019, represented our best success in most recent years with a 72% fill rate coupled with the fewest course cancellations since 2016. Many thanks to the hard work that Dr. Wise along with Division Coordinators and other faculty contribute to this.

SSCC Connect: As part of the college wide effort to stay connected with our current students, Advisors are reaching out to their students who have not yet registered for fall term. The Academic/Career Advisors on each campus have been assigned to specific programs or student populations in order to develop relationships and maintain consistency in the academic pathway identified for each student.

### **Gainful Employment Update**

The Department of Education is updating requirements for Gainful Employment programs. All one-year certificate programs are considered Gainful Employment programs and are subject to the update. The mandate requires additional compliance on the disclosure notice already available to view on the College's website for each Certificate program pathway.

The new mandate will require the College to update the disclosures in addition to providing all prospective students enrolling in a gainful employment program the disclosure notice directly. The disclosure includes the cost of the program, normal time to complete, median student debt for on time completers and a link to Southern State's information for the Department of Education College Scorecard -

<u>https://collegescorecard.ed.gov/school/?205966-Southern-State-Community-College</u>. In addition to providing the disclosure to the prospective student a confirmation from the student that they received the disclosure will be required. The financial aid office along

with admissions and registration are currently working to comply and implement the changes that go into effect July 1, 2019.

Invitations for 407 eligible students from fall semester were sent in March. Twenty-five members accepted. The goal is 15% acceptance rate to achieve the REACH award.

As the advisor has continued to work with students who have missed the invitation deadline to join the chapter, the efforts have resulted in 2 students receiving PTK scholarships, totaling \$29,000 per year.
