State Budget Update

On July 1, 2025, Ohio's Biennial Budget for fiscal year 2026/2027 was enacted. Among the higher education provisions, there were several notable outcomes that we had been watching closely. Among them include:

- State Share of Instruction (SSI) and Tuition Flexibility The budget included a 1% increase in SSI as well as a provision to authorize the Board of Trustees to increase tuition by up to \$10 per credit hour.
- Employment Outcomes While some aspects of this new funding mechanism were vetoed, the general spirit of the provision remained intact. Despite agreement that the data is difficult to verify, there is \$100 million in each fiscal year that will be distributed according to a formula devised by the chancellor. To leverage this provision more fully, it will be necessary for Southern State to graduate substantially more technical graduates in specific programs as designated by the Chancellor. Currently, our allocation is just over 1%.
- Redistribution of up to \$5.4 million in FY26 from the Community College SSI allocation for the final distribution of Eastern Gateway close-out.
- Technician Aligned Degrees Although the process for allocation has not yet been determined, additional funding may be accessed by the completion of technicianaligned associate degrees.

Overall, the final outcome was mostly consistent with our expectations. The allocations, which clearly prioritize student outcomes, provide a natural direction from which institutional goals can be established.

Education Provisions of "One Big Beautiful Bill Act"

In the days leading up to the One Big Beautiful Bill Act (O3BA), higher education was anxiously awaiting the final verdict on several provisions related to federal aid, student outcomes, loan repayment, and accountability, among other things. As reported in June, advocacy among colleges and universities appeared to be largely successful in diverting problematic adjustments

to the credit hour minimums for full- and part-time status. When the bill was unveiled on July 4, the existing definition for credit hours remained the same. Other provisions, however, including those related to an earning metric standard, are very much on our radar as colleges and universities are unwrapping the details of this standard. Today, it appears that loan eligibility for incoming students, in specific programs, will be contingent on a wage-earning metric for students who have previously completed the program and have median earnings that exceed the average income of high school graduates, ages 25-34. Clearly, there is much research remaining to understand how to obtain and monitor the benchmark.

Major Investment in Southern State to Scale the Ohio Code Scholar Program

As part of the Biennial Budget, Southern State was graciously awarded \$2.5 million (\$1M FY26 and \$1.5M FY27) for purposes of scaling the Ohio Code Scholar program across Ohio. Through the advocacy of Senator Shane Wilkin of Ohio's 17th District, and the talent of Dr. Josh Montgomery, alongside the project management expertise of Ms. Amy McClellan, this program has grown from a few students across several local schools to nearly a thousand participants across many schools, near and far. Southern State is both humbled and grateful to have such a substantial investment in our College to reach underserved populations and help advance their technology knowledge and skills. In collaboration with the Ohio Department of Higher Education and the Department of Development, the College is eager to begin shaping the formal scaling strategy and identify early target regions.

Strategic Planning Engagement to Commence

Early conversations with our planning consultant from Bellwether confirm a planning period of September to December, keeping us on track to finish our current plan and be ready with a new plan in 2026. The executive team and I have been working to identify the Steering Committee representatives, including representation from the Board of Trustees. Additionally, we have been putting some early suggestions forward for stakeholder engagement participants, including survey populations, focus group contributors, and individual interview participants. A SharePoint has been established, and we are actively loading the page with reports and information that will help frame the environmental context.

Update on Strategic Enrollment Management Project

Congratulations to the entire Southern State team, and particularly those who have been actively involved in the Steering Committee and work groups, for completing the heavy lift of Phase I & II of the Strategic Enrollment Planning Project. The project officially migrates from "planning" to "management" as the work in Phase III & IV gets underway. A complete

summary is available in your packet, and **Ms. Amy McClellan** will provide additional insights during the meeting.

OACC Executive Director Visits Southern State

We were honored to have the opportunity to host Avi Zaffini, Executive Director of the Ohio Association of Community Colleges, on campus in early August. In addition to the updates and campus tour the Southern State team shared with him, he reciprocated by updating us on how OACC can support our efforts and his vision for the organization going forward. As part of his visit, Mr. Zaffini spent time with the Executive Leadership Team and was able to tour the campus and meet guests who happened to be on campus that day. We are thankful for the relationship we share with OACC and for Avi's local and extended team's contributions to helping Ohio's community colleges remain competitive in Ohio's higher education landscape.

ACADEMIC AFFAIRS

Opening Week of Fall Semester

Our Fall semester begins Monday, August 25, and the week of August 18 is opening week for faculty and staff. The week includes a variety of meetings and professional development opportunities including an All-College Meeting, a Keynote Speaker (Dr. Bob Haas, OACC), academic faculty meetings and trainings, kick-off of the year's Deep Data dive series, sessions from our health plan vendors, as well as social events like an all-campus lunch, and the "Perk Me Up" Strategic Enrollment Plan Appreciation Break. Selected staff have online drop-in sessions for our adjunct faculty, as well as our CCP instructors and high school counselors.

Of course, getting students registered for Fall is our top priority! Several departments will be open on Saturday, August 23, to assist students with registration, advising, admissions, financial aid, learning services and accessibility, library, bookstore, IT, Testing Center, and Business Office. There will also be a "Fall into 50" event on that Saturday. The Marketing department will have sweet treats to celebrate our 50th birthday!

Higher Learning Commission Comprehensive Visit

The HLC will visit campus April 13 and 14, 2026, as part of the Commission's Comprehensive Review. The final report and supporting materials are due to HLC by March 16, 2026. Our Federal Compliance report is due in October 2025. There are currently two writing teams for the review: an assurance argument writing team and a federal compliance writing team. Adjunct | CCP Faculty Professional Development Event

On Wednesday, July 23, the Adjunct Faculty Committee hosted the annual Adjunct | CCP Faculty Professional Development Event on Central Campus. Thirty (30) faculty participated in the event – (4) adjuncts | (26) CCP teachers. There were also more than 20 SSCC staff and

faculty in attendance. Topics covered during breakout sessions included: Library Services & Resources; Mental Health Concerns; AO/ChatGPT; Simple Syllabus; CCP-Specific Q&A; and CANVAS. The attendees enjoyed a nice lunch catered by Rachel's House, WCH. The day ended with Division Meetings.

Transfer Activities

Transfer fairs for students looking to continue their education beyond their associate degree are scheduled in the 9th week of the Fall and Spring semesters. Transfer partners from public and private institutions in Ohio, Kentucky, and Indiana participate in the events. Students focused on a 2 + 2 transfer with partner schools are connected with advisors at intended institutions to ensure a smooth transition of coursework and pathway onto their bachelor's degree. Southern State staff will be presenting at two conferences this fall with several partners on seamless guided processes for community college students to bachelor's degree programs.

Brown County Campus

Summer session activities were a healthy blend of students in classes and community partners facilitating trainings and workshops. Summer academics were predominantly nursing, science (chemistry/biology), and truck driving courses. Full tutoring support (face-to-face and Zoom) for Math and Science courses was offered twice weekly during the term.

Community partner activities included Chamber special events and county leadership training, Educational Service Center Steamology training and preparation, Business Advisory Council for career technology opportunities, County Economic Development industry partner recruitment, and local social services training sessions. This Fall, the SSCC Brown County campus is the host site of Brown Leads Youth Academy (Chamber Leadership program for high school juniors and seniors).

STUDENT AFFAIRS

Student Affairs Annual Summer Retreat

The Student Affairs team participated in an in-house retreat on Monday, July 21. The primary purpose of the event was to strengthen the *team* through various activities. A discussion was held about the importance of and how to achieve work-life balance.

Accessibility and Learning Services (A&LS)

Accessibility Services (AS) | Summer 2025

- We have 22 students registered with Accessibility Services.
- We have proctored 31 exams (Hillsboro and Mt. Orab).
- Five new students registered with Accessibility Services in preparation for Fall 2025.

Learning Services (LS) | Summer 2025

- Summer term Tutors/Coaches had approx. 70 tutoring sessions with students since the term started on May 26.
- We have and continue to offer 60-70 hours of tutoring. This availability is for both campuses and includes online/Zoom tutoring options.
- LS is continuing to partner with the Nursing department on the launch to help students attain a passing score on the Nursing HESI Entrance Exam. This program was launched in May 2025. The goal is to help students who do not pass this exam on their first attempt to remediate so they can pass on their second attempt to help gain admission to the Nursing program. Approx. 50 students have started the process with approx. 50% seeing enough improvement to take the test for a better score. Working with the Nursing department on getting updated data.

Admissions

Although we are down a couple of CCP schools participating in the Fall 2025 term from last fall, we are currently up on the number of CCP onsite classes offered *from* 71 to 84 (if all classes have registered students). High schools' onsite registration will start coming in once schools start to return. The majority will be returning mid-August.

Fall CCP applications are still coming in. Typically, the CTC schools do not know their students until fall, so many applications are late. If the same occurs this year, we are on the way to having an increase in CCP applications. Last year, there was a total of 1124 CCP applicants for summer/fall. To date this year, 1094 students have applied through CCP.

Financial Aid

Southern State Community College's Financial Aid Program Participation is scheduled for reauthorization this fall. This is an essential compliance practice that determines the College's ability to offer financial aid. The reauthorization process, led by the Financial Aid department, includes oversight of essential policies and practices. The reauthorization application has been submitted well in advance of the September 30 deadline. Upon receipt, the Department reviews the application and asks for additional documentation if needed.

1,629 FAFSA applications were processed by Financial Aid for the 2024-2025 academic year.

INFORMATION TECHNOLOGY AND INFRASTRUCTURE

Copier Fleet Replacement

After twenty years with the same copier vendor, Southern State recently signed a five-year lease with Woodhull USA, a reputable copier and print solutions provider that serves the Cincinnati, Dayton, and Columbus area. Woodhull was selected from five bidders vying to provide our copier fleet service.

This process allowed us to restructure and reduce our copier footprint based on employee input about utilization and current needs, while maintaining the same copier brand and interface that

employees are accustomed to. We are encouraged to see that Woodhull is already providing exceptional service. This project was a lengthy and complex process, and we are pleased to report that we anticipate an annual savings of \$67,500. Special thanks to **Tyler Bick** (Technology Coordinator) for his detailed work to make this project a reality.

Computer Science Renovation Project

BHDP is actively working on the design phase of the Computer Science renovation project. Additionally, the design will include a small portion of the adjacent student services office complex. With the pre-design and schematic design phase complete, the team is moving into design development. We still anticipate a construction start in January 2026.

Adult Opportunity Center Building Renovation

Renovation efforts are moving along well. The facilities team is continuing to remove old material and assess the needs while seeking quotes for repair work and new furnishings that involve the roof, drywall repair, HVAC systems, flooring, ceiling tile, restrooms, etc.

The project will transform the former daycare operations into a modern professional workspace for additional classroom and office space for the Adult Opportunity Center, Workforce Development training, and other community meetings and events. Special thanks to **Loren O'Cull** (Facilities Manager), **Jeff Knauff** (Facilities Technician), and **Steve Bikowsky** (Maintenance) for their hard work on this project.

Central Campus HVAC Renovation

Six of the ten failed heat pumps have been replaced, and the four remaining units are scheduled for completion by the end of September. However, we are still focusing on completing the design for the larger project, which includes boilers, controls, and remaining heat pumps.

Design and space changes required for the Computer Science renovation project have led to some mutual planning for HVAC needs between Heapy Engineering and BHDP. The two teams are working together to determine the best path forward for this space and its impact on the larger HVAC project.


