5. Reports from Committee Members	<p>Nicole Sheppard discussed that the program is doing well. 10. Plan of Action <i>(for those listed in #9)</i>	<p>Goal 1: Strengthen Ethical and Professional Behavior among Future Early Childhood Educators</p> <p>Issues Addressed: Lacking ethical behavior; responsible conduct in the workplace.</p> <p>Strategies:</p>	

1. **Integrate an Ethics Module** into core ECE courses focused on professional responsibilities, confidentiality, boundaries, and decision-making aligned with NAEYC's Code of Ethical Conduct.
2. **Use Case-Based Learning** where students analyze real or simulated ethical dilemmas that early childhood professionals face.
3. **Require Reflective Journals** where students regularly reflect on ethical scenarios from coursework and practicum experiences.
4. **Establish a Professional Expectations Contract** signed by students during orientation to emphasize accountability, reliability, and integrity.
5. **Invite Guest Speakers** (Head Start directors, experienced teachers, licensing representatives) to discuss real-world ethical challenges and consequences of unethical behavior.

Goal 2: Build Strong Interpersonal and Teamwork Skills among Students

Issues Addressed: Personality conflicts; inability to work collaboratively.

Strategies:

1. **Embed Team-Based Assignments** that require cooperation, conflict resolution, and shared responsibility.
2. **Provide Direct Instruction on Professional Communication** (active listening, empathy, feedback, and handling disagreement) within classroom management or guidance courses.
3. **Offer Workshops or Micro-Credentials** on "Workplace Soft Skills" and "Professionalism in the Classroom."
4. **Include Peer Feedback Processes** in group projects to build self-awareness and interpersonal accountability.
5. **Incorporate Simulated Team Scenarios** (for example, co-teaching exercises) where students must plan and problem-solve together.

Goal 3: Promote Ethical and Responsible Use of Artificial Intelligence in Educational Contexts

Issues Addressed: Unethical or uninformed use of AI tools.

Strategies:

1. **Develop a Mini-Module on Digital Ethics and AI Literacy** emphasizing responsible use, data privacy, plagiarism, and AI bias awareness.

2. **Integrate AI Tool Demonstrations** showing appropriate ways to use AI for lesson planning, documentation, and professional growth.
3. **Create an AI Use Policy** specific to the ECE program that outlines ethical boundaries and expectations.
4. **Facilitate Reflective Discussions** on how AI can support or hinder relationships and authenticity in early childhood settings.
5. **Collaborate with Technology Faculty** to co-teach sessions that merge technology competence with professional ethics.

Goal 4: Enhance Critical Thinking and Reflective Decision-Making Skills

Issues Addressed: Lack of critical thinking skills.

Strategies:

1. **Implement Problem-Based Learning (PBL)** projects where students must research, analyze, and propose solutions to complex ECE issues (for example, classroom behavior, parent communication, curriculum design).
2. **Use Observation and Reflection Assignments** that require students to interpret child behavior and justify their instructional responses.
3. **Incorporate Socratic Questioning Techniques** in discussions to encourage deeper reasoning and evidence-based thinking.
4. **Add a Capstone Portfolio Requirement** where students analyze how their coursework demonstrates growth in decision-making and problem-solving.
5. **Train Faculty in Embedding Critical Thinking Prompts** and assessment rubrics aligned with Bloom's higher-order cognitive skills.

Goal 5: Strengthen Partnerships with Employers to Reinforce Workplace Readiness

Issues Addressed: Disconnection between academic preparation and employer expectations.

Strategies:

1. **Host Biannual Employer Advisory Meetings** to continue identifying emerging needs and validating curriculum updates.
2. **Collaborate with Employers to Develop Practicum Rubrics** that explicitly assess ethics, teamwork, and critical thinking.
