

# Southern State Community College Adult Incentive Scholarship

This scholarship is an incentive for adults who meet the requirements listed below to explore the value of a college education without making a significant financial commitment. With this scholarship, students have the opportunity to receive one free class between 1 and 4 credit hours. Tuition is free; SSCC course fees, lab fees and books are not covered by the Adult Incentive Scholarship. The student must complete the Free Application for Federal Student Aid (FAFSA). Eligibility for the Pell Grant will be determined and the scholarship will pay up to the cost of tuition after the Pell Grant has been applied to the student's account.

Only those students who meet the following requirements for eligibility may apply for this scholarship.
